* Low to moderate income (LMI) eligibility is a critical component to meeting the HUD National Objective. DFA must confirm that the proposed project will, in fact, benefit the entire community in order to use ACS data. Therefore, DFA requires that all potential CDBG applicants receive DFA concurrence prior to the CDBG survey methodology deadline. DFA reserves the right to make the final determination on usage of ACS to fulfill the LMI methodology requirement.
