Leadership Lens

Our Current Fiscal Strength

New Mexico is in one of the strongest financial positions in its history, and that strength is paying off as we face potentially monumental external challenges.

The Special Legislative Session focused on helping protect New Mexicans from the impact of significant federal budget reductions. Congress has signaled reductions in key programs that hundreds of thousands of families rely on, including Medicaid and SNAP. Rather than waiting for the effects to hit home, we acted early.

This proactive approach is possible because of years of steady growth and disciplined fiscal management. New Mexico's recurring revenue now generates roughly \$12 billion annually, nearly double what it was just a few years ago. Strong economic growth, coupled with responsible budgeting and investment, has created a foundation that allows us to plan rather than react to crises.

Our financial resilience extends beyond the state budget. The State Investment Council manages more than \$66.5 billion in assets on behalf of New Mexicans, ensuring long-term stability and growth. This prudent investment strategy, combined with disciplined fiscal practices, has earned

notice from national bond rating agencies. Moody's currently assigns New Mexico an Aa2 positive rating and is even considering an upgrade. This is evidence that our state's financial health is among the strongest in the nation.

Even under the most severe economic stress tests conducted by the Consensus Revenue Estimating Group (CREG), New Mexico remains on a stable footing. While no state is immune to revenue challenges, New Mexico is better prepared than most other states.

Our financial strength is not abstract, New Mexican families are seeing the benefits through no-cost childcare and college, family tax cuts, major housing initiatives, and targeted solutions to federal funding shortfalls I previously mentioned. These investments are easing burdens today while creating opportunities for tomorrow.

The bottom line is clear: New Mexico's finances are stronger than ever. This progress reflects years of careful planning, disciplined budgeting, and the leadership of both Governor Lujan Grisham and the legislature.

At DFA, our responsibility is to ensure this moment of strength translates into lasting opportunity. We are committed to building a future where every New Mexican experiences the benefits of stability today and the confidence of knowing the state is prepared for tomorrow.

State Agency ICIP Hearings

The FY 2027-2031 public hearings for New Mexico state agencies



regarding the Infrastructure Capital Improvement Plan (ICIP) will be held this month on Wednesday, October 15, 2025, Thursday, October 16, 2025, and Friday, October 17, 2025. Meeting invitations have been sent for each state agency's reserved time slot. The meeting notice and agenda can be found on the DFA

The deadline for presentation submissions was September 19, 2025. If a state agency missed this deadline and have items to present to the committee, documents must be brought to the hearing and copies distributed to each member of the committee. CAPS Overview

On September 10th, IPDD hosted its first training on the new Capital Projects System also known as CAPS. CAPS is our new platform that streamlines the capital planning and funding process by combining Infrastructure Capital Improvement Plans, (ICIPs), and quarterly reporting in the



same application. This centralized, unified system will automatically assign capital outlay appropriations to projects with an approved ICIP. The training provided an overview of the system and live demonstration on how to edit your entity profile, and your ICIP projects, prioritize your projects, and complete a quarterly report. To begin the process, entities should request access on the login page and choose CAPS as the module. After access is granted, you will be able to login with a temporary password. All entities should review the ICIP projects that were previously uploaded and re-submit them to ensure that all of the active appropriations are visible.

In the future, all awarded capital appropriations that are not connected to an ICIP will have an ICIP created so that all appropriations are tied to a plan. Planning is essential to success.

Capital Navigation and Funding Bureau Updates



Rural/Frontier Equity Ombud Report

The Infrastructure Planning and Development Division (IPDD) hit the ground running in fiscal year 2026, as did the office of the Rural/Frontier Equity Ombud.

Capacity Building Training Series I began in the fourth quarter of FY25, and carried into the first quarter through July, with well-attended sessions in Gallup, Roswell, and Taos. These sessions contain useful information and training valuable to local public bodies and to the core mission of the Ombud's Office. Other areas of inquiry which benefit rural communities included the topics of land and water conservation, and watershed protection.

Your local Council of Government (COG), or Economic Development District (EDD), are important partners with our coordinated efforts helping bring this resource to your neighborhood.

The Ombuds continue to provide needed capacity building and technical assistance to counties, municipalities, and special districts across New Mexico. Recent work focused on expedited audit capacity, compliance process improvement, state agency advocacy, capital appropriation navigation and grant agreement assistance, as well as ICIP assessment and prioritization.

The Ombud's Office also contributes to an advisory group developing a web-based Technical Assistance Inventory Tool, for use by all local public bodies, which when ready, will be introduced state-wide to New Mexican communities.

Community Development Block Grant Updates



CDC Application Hearing

The Infrastructure Plannin and Development Division (IPDD), held the virtual New Mexico Community Development Council (CDC) Application Hearing September 25 to review the 2025 CDBG applications. The Chair of the CDC Wesley Billingsley presided, and

eight Councilors participated. Representatives from 16 communities presented applications totaling \$31.6 million. The HUD award for FY 2025 is \$10,946,097. A link to the **recording** is here.

The Cost of Administering a Federal Grant

Making the Most of the 15% *De Minimis* Indirect Cost Rate

When organizations receive federal grant funding, it's important to understand how much can be



recovered for everyday operating expenses. Federal regulations under 2 CFR §200.414(f) allow eligible entities—those that have never had a negotiated indirect cost rate—to use a 15% de minimis indirect cost rate applied to Modified Total Direct Costs (MTDC).

Indirect costs cover the behind-thescenes expenses that keep programs running, such as office space, utilities, administrative staff, and technology systems. These costs are essential for

delivering federally funded projects but are not always easy to assign to one specific activity. By electing the 15% *de minimis* rate, organizations can recover a fair portion of these overhead costs without going through the lengthy process of negotiating a formal indirect cost rate with the federal government.

Using the *de minimis* rate can be especially beneficial for small local governments, nonprofits, and tribal entities. It reduces administrative burden, ensures compliance, and provides predictable funding to support core operations.

The 15% *de minimis* rate under **2 CFR Part 200** is a practical tool to strengthen financial sustainability and make federal funding more accessible, equitable, and impactful for communities.

Updates for Grant Administrators

Federal Grant Closeout Updates



As of October 1, 2024, several

changes were made to the Uniform Guidance for Federal Grants, one of which was an update to the grant closeout and reporting process. The citation is in the Uniform Guidance, 2 CFR 200.403(h) under section 200.403, which describes the allowability of costs, and is designed to streamline the grant closeout process and increase efficiency.

Previously, all costs, with limited exceptions, had to be incurred within the project's performance period, which typically was a deadline months before the final program end date. The updated guidance creates an exception, allowing administrative costs for closing out the award to be incurred and charged after the performance period has ended, and up until the deadline for submitting final reports. This reduces the administrative burden and provides grantees additional time to spend remaining funds and recover those costs by the final program deadline.

Grant funds must now be expended by the due date of the final reports; and charged to the final budget period of the award, unless otherwise specified by the Federal funding agency. Updating and expanding the grant end dates is a benefit to grantees allowing for additional time to spend and draw down remaining funds.

Federal Grants Bureau Relaunches and Rebrands Its State Single Point of Contact (SPOC) Process

The New Mexico Department of Finance and Administration's Federal Grants Bureau (FGB) has officially relaunched and rebranded the state's

Single Point of Contact (SPOC) process as the **New Mexico Federal Funds Clearinghouse**—a bold step to strengthen federal grant application reviews and interagency collaboration. Originally established under President Reagan's Executive Order 12372, the SPOC process ensures that selected federal grant applications receive coordinated statelevel review.

The relaunch transforms the SPOC process from a compliance checkbox into a comprehensive grant support system. Key improvements include a single-entry intake portal, a structured grant review checklist for consistent, actionable feedback, and dedicated training and assessment standardization for reviewers. Beyond the formal EO 12372 review, the Clearinghouse will evaluate all federal grant proposals, offering agencies constructive feedback to enhance competitiveness.

A phased rollout began in May 2025 with SPOC reviews and continues through 2026, expanding to include state agencies and local entities as reviewers. Upcoming milestones include publishing detailed policies, building a statewide letters-of-support contact list, and integrating intergovernmental review into the state's MAPS system.

By streamlining submissions and fostering collaboration across agencies, the New Mexico Federal Funds Clearinghouse is poised to improve compliance, and anticipate matching-fund requirements. This modernized process equips New Mexico's public agencies to secure more federal funding and better serve communities statewide. More information can be found on FGB's website.

Funding Opportunities



2026 Capital Development Program Fund Application Open

The Infrastructure Planning and Development Division (IPDD) is pleased to announce that FY26 Capital Development Program Fund (CDPF) grants is now open for grant applications. Approximately \$26.5M is available for funding infrastructure projects. The applications will be reviewed and scored by IPDD before being submitted to the Legislative Finance Council (LFC) to review during their hearings taking place the week of November 17th. **The application closes on Monday, October 27th.**

Projects selected by IPDD and approved by LFC will be included in the 2026 Capital Outlay bill to be passed by the Legislature and signed by the Governor. The grant awards will be available July 1, 2026.

Grant funds are available for two categories of projects:

Construction: Projects with a total cost of less than \$5,000,000 are eligible for construction grants.

Planning and Design: Projects with a total cost exceeding \$5,000,000 are eligible for planning and design grants.


